The contract is put into place so you know exactly what a session with me entails and to ensure that I am able to deliver on your expectations. Please read all information carefully. Keep a copy for yourself and then sign a copy for my records. If you have any questions, please let me know before the event. Thank you!

1. Weslo Productions is not obligated to perform any services described in this agreement for the client if payment is not made two weeks before the scheduled event.
2. No part of any order, including previews will be delivered until the balance is paid in full
3. There is a \$30 return check/non-sufficient funds fee.
4. Studio/Videographer may substitute another videographer to take the video in the event of Videographer's illness or uncontrollable influences and scheduling conflicts. In the event of such substitution, Studio/Videographer warrants that the videographer taking the video shall be a competent professional.
5. If the Studio/Videographer cannot perform this contract due to fire, or other casualty, strike, act of God or other cause beyond the control of the parties or due to Videographer's illness or emergency, then Weslo Productions shall return the retainer to the client but shall have no further liability with respect to the Contract. This limitation on liability shall also apply in the event that film materials are damaged in processing, lost through camera malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of Weslo Productions. In the event Weslo Productions fails to perform for any other reason, Weslo Productions shall not be liable for any amount in excess of the retail value of the client's order.

6. We take the utmost care with respect to the exposure, editing and production of all products and services offered. Every effort will be made to assure satisfaction according to Weslo Productions professional standards. However, Weslo Productions is not responsible for subjective interpretations of videography.
7. It is the client's responsibility to see that the person(s) to be videoed are available, on time and cooperative.
8. Weddings and events are dynamic and fast moving. While we make the best effort possible, we do not guarantee that everyone will be captured on film, nor do we guarantee the exact number of film of any one person at the wedding, or the exact total count of film.
9. Wedding coverage is contiguous. With hours based off of your selective package. The client is requested to provide a meal for the Videographer and any additional assistants, if applicable.
10. Client shall agree that all requests for copies, digital copies or any offered services will be submitted 6 months of the wedding date. Any products ordered after this period will be charged at current studio prices.
11. Basic facial blemish and stray hair retouching is subject to a \$50 subject fee, per shot. Additional retouching requires a custom quote.
12. Weslo Productions reserve the right to use film, video, and digital reproductions for advertising, display, publication or other purposes. Film, Hard-Drives Digital Files and Tapes remain exclusive property of Weslo Productions.
13. Digital Copies are available for purchase, but are included with the Premier, Trademark and Summit packages.
14. Product credit has no monetary value outside of the Studio's product and services.

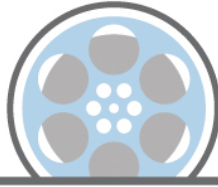

15. RETENTION OF ALL MEDIA: (Tapes, Film, Digital Copies, etc): Client agrees to place their final paid order within 120 days. After 120 days all orders will be considered complete and all film, data and tapes will be disposed of accordingly.
16. Upon signature and payment of the retainer (50% of the package price), the Studio shall reserve the date agreed upon, and will not make other reservations for that date. For this reason, all retainers, partial payments, credits and fees, including payments made by a third party in the name of the bride or groom, are non-refundable and non-transferable for any other service even if the date of the EVENT is changed or the EVENT is canceled for any reason.
17. METHOD OF CANCELLATION: In the event of a cancelled or rescheduled wedding, Weslo Productions requires notification in writing signed by the contacted party sent via Certified Mail by the United States Post Office, prior to the wedding date. This is the method of cancellation agreed upon by all signing parties and the only method of cancellation that will be accepted.
18. In the event of a cancellation or postponement within 60 days of the event, the total amount of the contract is due as scheduled and is non-refundable.
19. The charges in this Contract are based on the Studio's Standard Price List. This price list is adjusted periodically. Future orders shall be charged at the prices in effect at the time when the order is placed.
20. NOTICE OF COPYRIGHT: It is illegal to copy or reproduce these videos, digital files without Weslo Productions written permission. Violators of this Federal Law will be subject to its civil and criminal penalties.
21. It is understood that the terms videographer, studio, we and us is referred to Weslo Productions and/or Nate Westerfield. It is also understood the terms, you, them and they are referring to the client.
